

# Rules and conditions of participation in the prize competition “Jump to Planica 2018”

## I. Name of competition

“Jump to Planica 2018” (*hereinafter: the competition*) is a prize competition in which the organiser will award prizes to the six participants with the highest scores in the game “Jump to Planica 2018” who meet all of the conditions for participation as follows from this document.

The awards are:

- 1st place (first and second day of the conference) for the longest jump of the day: Ticket for one person to see the World Cup finals in Planica (Friday or Saturday).
- 2nd place (first and second day of the conference) for the second-longest jump of the day: Ticket for one ride on the Planica Zip Line.
- 3rd place (first and second day of the conference) for the third-longest jump of the day: Guided tour of the Planica Nordic Centre for one person.

## II. Duration of the competition

The competition will be held at the Portus Conference Centre (Kongresni center Portus) in Portorož, **on 22 and 23 November 2018** as part of the Sporto Conference 2018, which is organised by Sport Media Focus d.o.o.

## III. Definition of terms

The organiser of the competition is Zavarovalnica Triglav d.d., Miklošičeva 19, 1000 Ljubljana.

The rules of the competition (hereinafter the rules) define set out procedures and conditions under which players can participate in the competition. The applicable rules and conditions are published on the website [https://www.triglav.si/nagradne\\_igre](https://www.triglav.si/nagradne_igre) and are available from the Marketing Department at the headquarters of Zavarovalnica Triglav d.d., Miklošičeva 19, 1000 Ljubljana.

Any player who agrees to the rules of the competition may participate in the competition.

## IV. Participation in the competition

Players must be natural persons 14 years or older who carry out the following activities at Zavarovalnica Triglav's Oculus Rift stand at the Sporto Conference 2018:

- take a virtual-reality ski jump at Planica using an Oculus Rift headset,
- sign a Waiver of Liability,
- confirm by signature that as a participant in the prize competition they agree to its rules.

Persons younger than 15 must obtain the signed consent of a parent or legal guardian in order to participate in the competition.

Persons who are employed by the organiser of the competition and their immediate relatives may not participate in the competition.

Consent to the processing of personal data for purposes of direct marketing, segmentation and profiling is not a condition for participation in the competition.

#### **V. Winner selection procedure**

The organiser will award prizes to the six participants with the highest scores (three winners on each day of the conference) in the game "Jump to Planica 2018" who meet all of the conditions for participation as follows from this document.

Participants will receive a certain number of points for each virtual-reality ski jump at Planica. The winner will be the player with the highest number of points. Each participant may make several jumps, but may only receive one prize.

The organiser's decisions on all issues relating to the selection of the winners and the rules shall be final and shall apply to all participants.

#### **VI. Announcement of winners**

The results of the competition will be announced on Monday, 26 November 2018 on the website [https://www.triglav.si/nagradne\\_igre](https://www.triglav.si/nagradne_igre).

#### **VII. Prizes and picking up prizes**

The organiser will award the following prizes:

- 1st place (first and second day of the conference) for the longest jump of the day: Ticket for one person to see the World Cup finals in Planica (Friday or Saturday).

- 2nd place (first and second day of the conference) for the second-longest jump of the day: Ticket for one ride on the Planica Zip Line.
- 3rd place (first and second day of the conference) for the third-longest jump of the day: Pass to the Planica Nordic Centre for one person.

Prizes are non-transferable and non-refundable, and may not be exchanged for cash.

The winners shall bear all costs of acceptance of prizes and shall use the prizes at their own risk.

The winners will be notified of their prizes by email no later than 26 November 2018 and can pick up their prizes under their own name at the headquarters of the organiser, Zavarovalnica Triglav d.d., Miklošičeva 19, Ljubljana.

The organiser reserves the right not to confer the awards if doubts arise as to the veracity of the identity of the participant, if it is established that the participant participated counter to these rules, or if it is established that the participant abused the technical or other possibilities for participation and increased their possibilities of winning in an unfair manner (e.g. by automated means).

### **VIII. Privacy and data protection**

At Zavarovalnica Triglav we are aware of the importance of the human right to privacy and of the responsibility of companies that administer databases of personal data to protect personal data and its use in accordance with regulations and the principles of good practice, and we pay particular attention to communication with customers. Below we provide important information on the processing of your personal data. Upon your consent to these conditions, Zavarovalnica Triglav d.d., Miklošičeva 19, Ljubljana (Triglav, the organiser of the competition) may process your personal data in accordance with the provisions of these rules and conditions of participation in the prize competition “Jump to Planica 2018”. Triglav will process your personal data exclusively for the purposes set out in this section of the rules and conditions for the prize competition “Jump to Planica 2018” and for the purposes to which you have specifically consented.

Upon completion of the “Waiver of Liability” form, Triglav will collect the following personal data from you: Name and surname, postal address and email address.

Triglav processes the personal data in the registration form for the following purposes:

1. organisation and implementation of the prize competition,
2. notification of prizes,
3. publication of names and surnames on the website [https://www.triglav.si/nagradne\\_igre](https://www.triglav.si/nagradne_igre),
4. processing of data on winning participants for tax purposes (in the event of a winner who wishes to collect his/her prize, Triglav will also process their permanent/temporary residence and tax number),

5. the purposes of processing to which you have specifically consented.

Triglav will store the data that it processes for the purposes set out in points 1 – 3 of the previous paragraph for a further 12 months after the conclusion of the competition; the personal data that it processes under point 4 of the previous paragraph will be stored until the expiry of the statute of limitations in accordance with tax regulations; the personal data that it processes under point 5 of the previous paragraph will be stored until the withdrawal of consent on your part, unless otherwise stipulated by law for a particular type of personal data.

Your personal data may on behalf of and for the account of Zavarovalnica Triglav and in accordance with its written instructions also be processed by Triglav's contractual partners, with which Triglav has concluded agreements on processing personal data. Information on the categories of contractual data processors and information on the categories of users of data in Triglav's databases is accessible pursuant to the Privacy Policy on Triglav's website [www.triglav.si](http://www.triglav.si).

Individuals can temporarily or permanently revoke their consent to the processing of personal data or object to the processing of their personal data for direct marketing at any time, or demand access to, amendments to, corrections to, restrictions to the processing of, transfer of or deletion of their personal data, or lodge an objection to the processing of personal data processed in relation to them by sending a written request to the following address: Zavarovalnica Triglav d.d., Miklošičeva cesta 19, 1000 Ljubljana, or [info @triglav.si](mailto:info@triglav.si) or using the online form available at the company's website [www.triglav.si](http://www.triglav.si).
